WHEREAS:
The University Technology Fee Advisory Board (UTFAB) and University Facility Fee Advisory Board (UFFAB) must hold an open forum prior to a fee increase proposal to generate student opinions; and,
WHEREAS:
The University Technology Fee Advisory Board and the University Facility Fee Advisory Board have seen minimal attendance of non-involved students at the fee increase proposal open forums; and,
WHEREAS:
There needs to be a more convenient way for students to attain information from these forums to have their voice heard; so,

THEREFORE BE IT HEREBY ENACTED:	
That the University Technology Fee Advisory Board and the University Facility Fee Advisory Board record both video and audio of their fee increase proposal open forums by using a university sponsored recording device; and,	
THEREFORE BE IT HEREBY FURTHER ENACTED:	
That a link to view this recording will be posted on the ASCSU website and the adjacent UTFAB/UFFAB websites so students have access to the recording; and,	
THEREFORE BE IT HEREBY FURTHER ENACTED:	
That the chair or vice chair of the University Facility Fee Advisory Board and University Technology Fee Advisory Board meet with the chair of the Classroom Review Board prior to and after an open forum to arrange logistics of properly recording the open forum and placing a link to the forum recording on the ASCSU/UTFAB/UFFAB website; and	
THEREFORE BE IT HEREBY FURTHER ENACTED:	
That a copy of this legislation be forwarded to the ASCSU Vice President, ASCSU Senate Speaker Pro Tempore, University Technology Fee Advisory Board Chair, University Facility Fee Advisory Board Chair, Classroom Review Board Chair, Jason Huitt-UTFAB Liaison, Rusty Scott-Associate Director of ACNS, Steve Hultin-UFFAB faculty advisor.
