#### **WHEREAS**

Section 200 of Article II of the Constitution of the Associated Students of Colorado State University states:

"There shall be an ASCSU Senate, which shall facilitate student activities at Colorado State University within the limits placed upon it by this Constitution. It shall further act as liaison to any faculty or administrative bodies of Colorado State University and to any other organized bodies whose actions have a bearing upon the members of ASCSU;" and,

#### **WHEREAS**

Section 201 of Article II of the Constitution of the Associated Students of Colorado State University states:

"The Senate shall have the power to initiate and enact any legislation necessary and proper under this Constitution; to delegate its authority as it deems fit; to approve all appointments to any body to which it has delegated authority as well as the standing officials in the Executive, and Supreme Court Justices; to affiliate ASCSU with any inter-collegiate or intra-collegiate organizations; to call for special elections; to oversee and manage their affairs as they deem proper; and to remove from office any negligent official as defined in section 605;" and,

#### **WHEREAS**

Section A of Article III of the Bylaws of the Associated Students of Colorado State University Senate states:

"The Senate shall meet each Wednesday, at 6:30 p.m., throughout the academic Fall and Spring semesters when class is in session, excluding finals week;" and,

#### **WHEREAS**

The guest speaker list currently has no time limit and can push back the start of Senate considerably; and,

#### **WHEREAS**

The guest speaker list currently comes up after roll call in the agenda; so,

# THEREFORE BE IT HEREBY RESOLVED

That Roll Call be moved to after the guest speaker list in the agenda with the guest speakers only being given 30 minutes total to present, causing Senate to be started at 7pm each night; and,

### THEREFORE BE IT HEREBY FURTHER RESOLVED

That Section A of Article III of the Bylaws of the Associated Students of Colorado State University Senate be amended to read as follows:

"The Senate shall meet each Wednesday, at 7 p.m., throughout the academic Fall and Spring semesters when class is in session, excluding finals week;" and,

That since there still exists many valuable and esteemed speakers on and around campus, if one such of these speakers is deemed valued enough by the Vice President, may be given 15 minutes after Roll Call to speak to Senate.
