Any legislation not following this process may be deemed by the Speaker as out of order and not added to the agenda."; and,

## **WHEREAS**

Section E of Article III of the Associated Students of Colorado State University Senate Bylaws states that:

"Guest speakers shall be submitted to the Speaker of the Senate by 10:00 a.m. Monday for inclusion in the next Senate agenda."; and,

### **WHEREAS**

The Vice President and Speaker Pro Tempore have a Senate Leadership meeting schedule for Noon, 12:00 p.m., on Mondays; so,

#### THEREFORE BE IT HEREBY RESOLVED

Section C of Article IV of the Associated Students of Colorado State University Senate Bylaws be amended to read as:

"Bills and resolutions shall be in procedural form and submitted to the Parliamentarian, Speaker Pro Tempore, and the Speaker of the Senate by noon, 12:00 p.m., on the Monday before its first reading to ensure that all grammatical errors are corrected. Any legislation not following this process may be deemed by the Speaker as out of order and not added to the agenda."; and,

#### THEREFORE BE IT HEREBY FURTHER RESOLVED

Section E of Article III of the Associated Students of Colorado State University Senate Bylaws be amended to read as:

"Guest speakers shall be submitted to the Speaker of the Senate by noon, 12:00 p.m., Monday for inclusion in the next Senate agenda."; and,
