gian and i broke up after a year & a half relationship over the summer and ever since he hasn't respected my wishes to be left alone. for the past two weeks he has been really good at not contacting me over the phone, but every time i run into him in person he demands to talk to me and physically restricts me from walking away from him. last night outside of moby arena he repeatedly grabbed me by my arms and kept harrassing me until i stopped to talk to him. eventually he let me go, but this keeps occurring.
same situation

i've told him over and over again through a phone & in person to leave me alone and stop laying his hands on me. when he followed me out of moby and was pulling/grabbing me he ended up grabbing my backpack off of me and putting it on himself to make sure that i couldn't leave (my phone & keys were inside of my backpack).

AFFIDAVIT IN SUPPORT OF WARRANTLESS ARREST

Affiant, Katie Aron, being duly sworn upon oath, says that there is probable cause for the warrantless arrest of, Clavell-Lopez, Gian, 112693 for the crime(s) stated, and that the following facts are true and correct upon best knowledge, information, and belief.

Form with fields for Agency (CSUPD), Arresting Officer (Katie Aron / C7963), Charge Description (False Imprisonment, Domestic Violence), CRS Citation (18-3-303, 18-6-801), Class (M2), Agency Case Number (16 - 2588), Arrest Date (110916), Arrest Time (1840).

The facts establishing probable cause for arrest are that on 110316 at 1900, in the county of Larimer, State of Colorado, at 951 W Plum Street the following activity occurred:

On 11/04/16 at 2155 hours, I was dispatched to an assist over the phone. [redacted] called CSUPD to inquire about how to get a restraining order against Gian CLAVELL-LOPEZ. [redacted] told me she and CLAVELL's relationship lasted for about a year and a half, from January 2015 - July 2016. I spoke to [redacted] on the phone and she came into the police department to fill out a statement. According to [redacted] on 11/03/16 at approximately 1900 hours, [redacted] was leaving to her car after practice and CLAVELL followed her outside of Moby Arena. CLAVELL was yelling and cussing at [redacted] to stop and to talk to him. CLAVELL then started to grab [redacted] arm and pull her back toward him. [redacted] was attempting to walk away the entire time CLAVELL was pulling her by the arm back to him; CLAVELL was detaining [redacted] without her consent. [redacted] told me that she told CLAVELL she wanted to leave and to let her go. CLAVELL forced her back and took the backpack she was wearing off of her back and put it on his own back. [redacted] said that CLAVELL knew her car keys, phone, and her wallet were in the backpack. [redacted] said that CLAVELL took the backpack from her so she had no way of leaving. [redacted] said in the interview, "He was trying to hold me back... there was a lot of force to it."

[redacted] texted CLAVELL later, "I wanted to walk away from you and you should've given me the freedom to do that no matter what."

CLAVELL came to CSUPD for an interview on 11/09/16 and told me he did grab her bag from her. CLAVELL told me he took her backpack off her. CLAVELL said "I was trying to make her do the right thing... I did not want her to go home mad... I was heated in the moment." CLAVELL said he knew her keys and wallet were in her backpack. I asked CLAVELL if he was trying to have her stay on his accord to make her talk to him. CLAVELL said, "yeah."

CLAVELL also told me he was in a relationship with [redacted] for about a year and a half.
