

## MANDATORY VS. PROPOSED STUDENT FEES

#### **Mandatory Costs**

- As a Board, we cannot deny these increases
  - Facility Increases
  - Minimum Wage/Salary Increases
  - Fringe Benefits
  - Tuition Increase (GA)

#### **Proposed Increases**

- As a Board, we vote on these types of increases
  - New Project/initiative cost
  - New personnel

# COMMITTEE FOR DISABLED STUDENT ACCESSIBILITY

- Asking for a \$2.22 fee increase
  - Why: Hiring a new accessibility specialist
  - Classified as: fee request above mandatory costs
  - **FY19 Fee Proposed**: \$2.70

# STUDENT LEGAL SERVICES

- Asking for a \$0.19 fee increase
  - Why: Minimum Wage and Salary/Fringe Increase
  - Classified as: Mandatory cost increase
  - **FY19 Fee Proposed**: \$7.49



# **INTERPERSONAL VIOLENCE**

- Asking for a \$0.10 fee increase
  - Why: Minimum Wage and Salary/Fringe Increase
  - Classified as: Mandatory/New cost increase
  - **FY19 Fee Proposed**: \$4.35
